3. Review of Previous Minutes

Minutes from the previous meeting held on 1 December 2015 were accepted as true and correct. No changes were suggested or made.

4. Presentation of 2016 Annual Report

- AS expressed gratitude and pride at delivering his first Annual Report as Club president following DM.
- The 2016 season success was noted with SUFC becoming Club Champions once again for 13th year in a row and Colts Champions.
- SUFC won 4 premierships from 7 in 2016.
- 2 new SUFC received their first Wallaby caps Tolu Latu and Tom Robertson.
- Off field, 86% of players are from the student cohort with 68% from USyd.
- Student pass rates have increased from 70 to 83%, with a strong representation of student continuing to further their studies.

5. Presentation of 2016 Financial Report

- AJ presented the financial status of the club*.
- The club remains debt free and in a strong financial position as it was in surplus of \$8,850 as at 31 October 2016.
- Total income for the year was \$1.2m, down 10.6% from the previous year.
- There were decreases across a number of income categories: Grants and Donations (down 3.6% to \$372,933); Home Gate and Sponsorship (down

4.9% to \$415,906); and Other Income. The decreases were partially offset with increases in Affiliation income (up 49.3% to \$92,189) and Fundraising Activities (up 1.9% to \$267,735).

- Total expenditure for the year was \$1,158,398 down 12.0% on the previous year. Reductions in expenditure were incurred in Rugby Operations (down 12.0% to \$578,244); Administration Costs (down 11.1% to \$235,932); and Fundraising Activities (down 1.3% to \$175,004). The decreases were offset by an increase in Marketing & Promotion (up 15.0% to \$11,658), with Development expenses in line with the prior year.
- * It was noted that during the meeting a figure presented in the annual report had been printed in error. Attendees removed the financial report with the correct figures to be provided in the copy of AGM published on the Club website.
